- For classes being offered **In-Person**, parking is available at meters on Jefferson Ave. paying meter fees using the Park Cbus App. or using the kiosk at the SE alley on the east side of Jefferson Ave. During the daytime (8am-6 pm) the rate is \$ .50/hr. No fees after 6 pm. Handicap parking spaces are located behind Action for Children.
